

**PORT CLINTON CITY COUNCIL MINUTES**  
**REGULAR MEETING**

The regular meeting of the Port Clinton City Council was held at the Port Clinton City Hall with Linda Hartlaub, President of Council, presiding. The meeting opened at 7:30pm. Council recited the Pledge of Allegiance, The Lord's Prayer, and a moment of silence for those serving our Country.

The role was called and the following Council members were present: Mike Snider, Gabe Below, Lisa Sarty, Beth Gillman, Jerry Tarolli, Nicole DeFreitas and Margaret Phillips.

Mr. Tarolli made a motion, seconded by Mrs. Sarty to accept the minutes as written from the September 23, 2014, October 14, 2014 and October 28, 2014 regular Council meetings. With all those in favor, motion carried.

The Chair noted the certification has been received regarding the compliance with the rules and notification of this meeting.

**PUBLIC COMMENT** Roger Smith, 218 W. 4<sup>th</sup> Street asked if the ordinance on the books regarding snow removal from sidewalks also applies to the businesses. Mr. Colston stated yes. Mr. Smith asked if they will be fined if they don't and Mr. Colston stated that they can be.

Rick Noderer, representing CORD, 608 E. Perry Street, stated that the results of Issue 6 are back and it passed by 38 votes. He thanked everyone who voted and he feels the results mean the citizens don't trust the city and if the city wants to develop, and then they will have to be open and honest with the citizens and what they want so they can vote. He hopes other communities follow in PC's lead.

**SECOND READINGS**

**ORDINANCE 24-14** AN ORDINANCE AUTHORIZING AND DIRECTING THE DIRECTOR OF SAFETY AND SERVICE AND THE CITY AUDITOR TO ENTER INTO A COOPERATIVE AGREEMENT FOR CONSTRUCTION, MAINTENANCE AND OPERATION OF STATE WATER AND SEWER PROJECT BETWEEN THE CITY OF PORT CLINTON, OHIO, AND THE OHIO WATER DEVELOPMENT AUTHORITY, AND DECLARING AN EMERGENCY

Mr. Snider made a motion, seconded by Mr. Tarolli to waive the required three readings for Ordinance 24-14. Mr. Snider stated this is time sensitive and is the first of many stages to secure a water line along 2<sup>nd</sup> & Jackson Street. The Finance Committee recommends the passage of Ordinance 24-14. Results of a voice roll call are as follows: Snider, yes; Below, yes; Sarty, yes; Gillman, yes; Tarolli, yes; DeFreitas, yes and Phillips, yes. With all those in favor, the three required readings for Ordinance 24-14 have been waived.

Mr. Snider made a motion, seconded by Ms. Phillips to retain the emergency clause for Ordinance 24-14. Results of a voice roll call are as follows: Snider, yes; Below, yes; Sarty, yes; Gillman, yes; Tarolli, yes; DeFreitas, yes and Phillips, yes. With all those in favor, the emergency clause for Ordinance 24-14 has been retained.

Mr. Snider made a motion, seconded by Mrs. Gillman to adopt Ordinance 24-14. Results of a voice roll call are as follows: Snider, yes; Below, yes; Sarty, yes; Gillman, yes; Tarolli, yes; DeFreitas, yes and Phillips, yes. With all those in favor, Ordinance 24-14 has passed.
