**Mr. Hild** – Parks and Rec is currently working on a coed volleyball team that will be starting in the fall. They are currently working on finalizing the details now and will update everyone once they are finalized. Asked Mr. Martin about the status of the land on the corner of Harrison and Fremont Rd. Mrs. Sarty stated that they property is currently owned by the Landbank and he would have to follow up with them.

**Ms. Phillips** – Asked if Council could receive a copy of liquor licenses when they are received going forward. Mrs. Pipoly will make copies and distribute to Council when one is received going forward. Reminded everyone that the Blessing of the Fleet is scheduled for May 9<sup>th</sup> at 10am.

**Mr. Freedman** – Asked Mr. Martin if he had any additional information in regards to the drawbridge project being postponed. Mr. Martin stated that it is a State project and they have no control over the progress. Asked for an update on the sidewalks downtown and the entire schedule for the tearing out and repairs of the sidewalks. Mr. Freedman asked Mr. Martin for an update on the mill and fill of Fremont Road. Mr. Martin stated that they currently looking to see if mill and fill is the right way to go. Mr. Martin stated that he believes the detour of the drawbridge is adding to the road deaerating and they were reaching out to the State to try and get some overages funds. Asked when Brush clean-up is. Mr. Martin stated that Brush clean-up is the second Wednesday of each month.

**Mrs. Sarty** – Arbor Day ceremony was on April 27<sup>th</sup>. It was a very nice ceremony and thanked Mr. Holman for arranging it. Reminder that brush clean up starts on May 14<sup>th</sup>. Reminded everyone that there is an Ordinance about grass clippings going onto the streets. Reminded everyone to not put junk on the side of the road and Republic only picks up what is inside the cans. Asked Mr. Martin about citizens having to use Republic if in town. Mr. Martin stated that yes the City of Port Clinton is exclusive to Republic. Mr. Freedman stated he does not use Republic services due to having issues with charges. He asked Mr. Martin if there is fine for not using Republic and Mr. Martin stated he is unsure. Mrs. Sarty stated that it is Birding Week. Ms. Phillip and she are volunteering at Maumee Bay State Park for a day during the event. Discussed at Parks and Rec committee meeting that the City put in a viewfinder by the Lighthouse. The expense to the city was the concrete being used for the pad. The City is also expanding the concrete slab at Lakeview Park on the east side to make it more accessible to get to the bathrooms. The accessibility park has been repaired and they are currently waiting on one more swing to come in.

**Mr. Below** – Student government day was today with none showing up this evening. The next finance committee meeting is postponed and he will send out the new date as soon as it is finalized. The liquor license previously mentioned will be on file with the clerk until the next council meeting for review.
