## **MAYOR'S REPORT**

A couple of weeks ago, there was a missing person in the City of Port Clinton. A big Thank You to the Port Clinton Police Department and Ottawa County Sherriff's Department in the assistance in locating the individual and returning them safely. Colin Haines a night shift employee at a downtown hotel reported that the individual came to the lobby the evening they were reported missing. His report to the authorities started a chain reaction in the search.

Last week the Port Clinton Chamber of Commerce hosted the National Walleye Tour at Waterworks Park. There were 140 professional anglers and 140 co - anglers that participated. During the two day event each pro was assigned a different co. Had many positive comments from participants.

## AUDITOR'S REPORT

Ordinance 11-24, is for \$4.5 million note issuance for Bond Anticipation Notes (BANs) for road phase 1 project. Requesting to consider adopting this evening due to time sensitivity.
